- Entry Fee:** Singles \$30; Doubles \$60 per team (\$30/person)
- Schedule:** **Juniors:** Boys and Girls 18U tournament will be played Thursday, July 9th. Boys and Girls 15U will be played on Friday, July 10th. Juniors matches will begin at 8:30 AM and should conclude with finals matches by 7:00 PM weather permitting

Adults: Play may begin Friday July 9th as early as 4:00 PM depending on draw sizes. It may not be possible to schedule players who are unable to play on Friday.

Adult events prior to semi-finals and all consolation matches. 6 game regular sets, No-ad scoring, 7 point tie-break at 6-6. 10 point super tie-break if players split sets. For semi-finals and finals - Regular game scoring, 10 point super tie-break if players split sets.
Tournament directors may adjust schedule and match lengths at their discretion due to inclement weather or extreme heat.
- Tennis Balls:** Tennis balls will be furnished for all matches
- T-shirts:** All entrants will receive a T-shirt. To guarantee a shirt in requested size, please enter by Tuesday, June 30th, 2026. We will do our best to honor all requested sizes, but may not be able to accommodate XS and XXL sizes due to quantity requirements when ordering.
